APPEARANCE:	Deep-red & oval shape goji berries varying from red light to dark red colour. Whole dried berries free flowing.		
TASTE:	Typical sweet of Goji berries with no off – odour and taste. Goji berries have a mild tangy taste that is slightly sweet and sour.
