DESCRIPTION:	Cloves are harvested at 1.5–2.0 cm long, and consist of a long calyx that terminates in four spreading sepals, and four unopened petals that form a small central ball. Cloves are the aromatic flower buds of a tree in the family Myrtaceae, Syzygium aromaticum.
APPEARANCE:	Whole
TASTE:	Tasted on its own clove is bitingly sharp, hot and bitter and leaves a numb sensation on the mouth. No off flavours or taints.
TEXTURE:	Whole
SMELL:	Strong, warm aroma. No off odours or taints.
