DESCRIPTION:	Flax (also known as common flax or linseed), with the binomial name <i>Linum usitatissimum</i> , is a member of the genus <i>Linum</i> in the family <i>Linaceae</i> . It is a food and fibre crop that is grown in cooler regions of the world. The oil is known as linseed oil. In addition to referring to the plant itself, the word "flax" may refer to the unspun fibres of the flax plant. The plant species is known only as a cultivated plant and appears to have been domesticated just once from the wild species <i>Linum bienne</i> , called pale flax.
